Short Term Tender Notice for purchase of electric vehicles .

SECOND ROUND TENDER

Tender Notice No. EV- 1 of 2015/16

1. Sealed Tenders are invited from manufacturers/suppliers three 11 Seater battery operated vehicles (Shuttle Bus Series) for use in Bhagwan Birsa Biological Park, Chakla, Ormanjhi, Ranchi.
2. The detailed desired technical specifications of vehicles are given below :-

**11 – Seater vehicles : (Shuttle Bus Series)**

1. Seats : 11 (Eleven)
2. Max speed with full load : 25-35 Km/hr.
3. Tyre : Tubeless 145 R
4. Motor : 4 to 5 Kw
5. Ground clearance  
with full load : 160 mm or above
6. Chesis : Steel (rust proof) Tubeless treated
7. Battery : 48 V
8. Steering : Automotive
9. Body : Fibre reinforced (upper) with 360<sup>0</sup>  
view
10. Brake : Hydraulic 4- wheel brake
11. Charger : Fully automatic smart charger
12. Windshield : Glass
13. Colour & Carpet : Purchaser choice
14. Other : Speedometer, both sides looking  
glass, wiper, headlight, parking light,  
brake light, music system.
15. Max distance cover  
per charging : over 50 Km.

16. Controller	:	PGS 1240 M
17. Curb weight	:	900 kg
18. Load Capacity	:	1100 kg
19. Dimensions	:	Length 15' to 16' (approx) Width – 6' to 7' (approx)

(3)(i) Bids will be given separately in two sealed envelopes, one containing the technical bid and the other, the financial bid superscribed as such. These two envelopes would be put in a bigger envelope, superscribed with the words “Tender for purchase of electric vehicles”.

(ii) The technical bid envelope will contain following documents :-

- (a) Tenderer’s complete identity and address.
- (b) Complete description, including technical specifications, of the vehicle, with coloured photograph of the same intended to be supplied.
- (c) Warranty terms for the motor, battery & body of the vehicle.
- (d) Sales Tax, VAT Registration (whichever is applicable) and up-to-date clearance certificate from the concerned department.
- (e) EMD @ 2% of the financial bid offer (in rupees) in the form of a Bank Draft of a Nationalized/ Scheduled Bank, made in favour of “Member Secretary, Executive Committee, Jharkhand Zoo Authority, Ranchi” and payable at Ranchi.
- (f) If the tender is given by the manufacturer himself, then copy of manufacturing lisenence from competent authority. And if the tenderer is a supplier, then he should be the authorized agent of the manufacturer and he will produce such authority letter issued by him.
- (g) The firm order for supply will be given within 30 days of the date of issue of purchase order and the price quoted by the tenderer should be valid till the actual supply is completed.
- (h) Terms and Conditions of Annual Maintenance Contract. However this could be negotiated later on.
- (i) Previous places where such vehicles have been supplied, with details like clients their address with telephone number etc, year of supply and number of vehicles supplied.

(iii) Financial bid envelope of only those tenders would be opened who would qualify in the assessment of their technical bids.

4. The price bid quoted should be quoted of vehicle, It shall be inclusive of all taxes, octroi and F.O.R. at zoo at Chakla, Oramnjhi, Ranchi (which is approx. 30 kms from Ranchi Railway Station). If there is any transport charge it should also be mentioned separately.

5. Payment is desirable to be made on completion of supply of these items. However, if any advance payment is demanded, then it will be made available against Proforma Invoice (P.I) and against a Bank Guarantee of a Nationalized/ Scheduled Bank, for an amount equal to 10%

more than the amount quoted in the P.I and for a period of six months from the date of award of work.

6. **The tenders would be received till 3.00 pm on 28.03.2016 in PALASH MEETING HALL, situated in Forest colony at Doranda, Ranchi (behind Van Bhawan) and the same shall be opened there on the same day at 3.30pm.**

7. Evaluation of the tender will be done by the Executive Committee of this Authority, whose decision shall be final and binding, reserving the right to reject any or all tender without giving any reason.

8. Preference shall be given to the quality, comfort, durability, appearance and of course low power consumption of the vehicle.

9. If any information provided by the tenderer is found false at any stage subsequently (i.e. after giving tender), his tender or the work order will be cancelled and the EMD amount or the Bank Guarantee equivalent to the EMD amount, which ever is applicable, will be forfeited.

10. Any postal or other delay, resulting in non- receipt of tender in time will not affect the tendering process and such tenders would not be evaluated.

11. If a vehicle with gear facility is available, it may be quoted separately.

12. The tender should be unconditional and the tenderer will give an undertaking that he will abide by the terms and conditions of this tender.

13. Any issue, which is not mentioned here and which may crop up later on, would be decided by the Executive Committee of the JZA.

14. The undersigned reserves the right to reject any or all tender without giving any reason and issue any corrigendum related to terms and conditions of Tender. The corrigendum will be uploaded on the website mentioned above. So the bidder are advised to visit the website before submission of bid.
